In a groundbreaking event, the Ancient Order of Hibernians hosted Taoiseach Leo Varadkar and U.S. Congressional staff members at an event

commemorating the Good Friday Agreement held at the Phoenix Park Hotel in Washington, D.C., on March 16. The event was the first time a Taoiseach of Ireland had made a visit to a Hibernian event as an item on his itinerary. The Taoiseach is the Head of the Government or Prime Minister of Ireland. In the words of President O'Connell, "The event was an opportunity to broaden our contact base on Capitol Hill. Many of the attendees were from Congressional offices that wouldn't normally be associated with Irish issues."

In speaking to the crowded room, the Taoiseach stated, "I think it's fair to say that, at critical junctures, the intervention of the U.S. drove the peace process forward when few others could have," "Your influence is felt not just in Dublin but also in Belfast, in London, and in Brussels. What America thinks about Ireland really does matter. Each time a crisis has arisen, the support of the U.S. has been sought, and it has been given generously.

"Irish Americans have pushed their representatives in government to keep Northern Ireland on the agenda. I am very grateful to the congressmen and senators and their offices who take an interest in Ireland and make sure it is part of the U.S. agenda."

The event was very successful, and the staffers, whose energy powers Washington but often goes unappreciated, were grateful that their important role is being recognized. The event brought new

# Former Taoiseach Bertie Ahern to receive Sean MacBride Humanitarian Award

In this, the year we recognize the 25th anniversary of the Good Friday agreement, the Ancient Order of Hibernians in America is proud to announce that Bertie Ahern will be the recipient of the Sean MacBride Humanitarian Award. Bertie's commitment to peace in the North of Ireland while serving as Taoiseach 25 year ago helped create the Good Friday Agreement. The AOH will present the award on this October 14th at the National Board Meeting in Youngstown, Ohio.

The Sean MacBride Humanitarian award memorializes the Human Rights contributions made by Nobel Peace laureate Dr. Sean MacBride and to recognize the efforts of others who make similar contributions in the cause of peace, justice and the economic well-being of the Irish people. The biennial award is a bust or likeness of Dr. Sean MacBride. The Award is conferred without regard to the nominee's race, creed, sex, religion, color or National Origin. Bertie Ahern is a signatory of the Good Friday Agreement.

Bertie Ahern retired as Taoiseach (Irish Prime Minister) in May 2008 having enjoyed the unique distinction in modern Irish politics of being the first person in over 60 years to have been elected to that office on three successive occasions.

He served as a member of Dáil Éireann (the Irish Parliament) for almost 35 years. He was first elected to the Dáil (Parliament) in 1977 for the constituency of Dublin-Finglas and he represented Dublin Central from 1981 until 2011

He was Minister for Labour from March 1987 to November 1991 and was appointed Minister for Finance on three separate occasions from November 1991 to December 1994. Ahern was first elected Taoiseach in June 1997; he was re-elected in June 2002 and again in May 2007. In 1997 his party was elected to government in coalition with the Progressive Democrats. This minority administration was supported by a small number of Independent members of Parliament. He received widespread praise for his political skills in ensuring that this administration served its full five-year term and delivered on real political and economic progress for the Irish people.

The defining moment of this period and a defining moment in Irish history was the successful negotiation by Bertie Ahern and Tony Blair of the Good Friday Agreement between the Irish and British Governments and the political parties in Northern Ireland in April 1998.

The Good Friday Agreement transformed relations for


the better between Ireland and Britain, between Ireland, North and South, and between different traditions within Northern Ireland. It instilled a new ethos of tolerance and respect into politics on the island of Ireland and between diplomatic relationships between the islands of Ireland and Britain.

Every Project St. Patrick Grant request was awarded; 67 from the AOH and 20 from the LAOH.

A record setting \$162,000 was distributed from our FFAI Christmas Appeal in the North of Ireland by the AOH.

The AOH hosted a reception during the D.C. St. Patrick's Day events with Taoiseach Leo Varadkar and congressional staffers we need to work with in the U.S. House and Senate from both political parties. This is the first time that Ireland's head of government, or prime minister, attended such an event.

The AOH donated \$23,000 via Project St. Patrick toward the formation of seminarians for the diocesan priesthood in Ireland.

The initial class of AOH St. Patrick Centre Ambassadors was selected and will include nine young Hibernians from around the country who will spend two weeks in Downpatrick this June learning about St. Patrick and the North of Ireland.

The AOH was invited to the White House for the Shamrock presentation as recognition of our leadership in Irish America.

The Father Flanagan Human Dignity award was created and will be presented at the National Convention.

The AOH was invited to the events related to the Presidential visit to Ireland as recognition of our role as leaders in Irish America.

The AOH was invited to have a panelist during the Good Friday Agreement 25th Anniversary event with President Clinton and Gerry Adams.

Bertie Ahern, Ireland's Taoiseach who signed the Good Friday Agreement accepted the 2023 Sean MacBride Humanitarian Award.

The list goes on and on.

I had the honor to meet with Aidan McAnespie's family in their home on Palm Sunday. I was moved deeply by this experience especially when they told me they were happy to finally get the hearing and trial but embarrassed that other families did not have the same opportunity. During my time in Ireland, I also participated in the Christmas Appeal Donations, met with EALU, The Omagh Choir, The Omagh Basketball Team, St. Patrick's Seminary in Maynooth, The St. Patrick Centre, Irish Central and many other friends of the AOH. It is incredible how many people in Ireland know the work we do. Each of you as a member are a part of every Hibernian accomplishment.

With all the great accomplishments of the Ancient Order of Hibernians, we must continue to work together as one. Remember, we are a multiple issue-based organization, and we can't detract from the work we do on one issue in attempt to demonstrate support for another.



The first several months of 2023 has brought with it a heightened visibility of the AOH that I have not experienced in my many years on the national board. Our membership should be rightfully proud, and we need to recognize the leadership and vision of our president, Danny O'Connell, whose hard work for and dedication to our Order has made a lot of these successes possible.

In January we continued our long-time support of Pro-Life by attending the National pro-life march in Washington, D.C.

In February I was proud to represent the National Board in Omaha, Nebraska, at the Father Flanagan Division Annual Award dinner to present Thomas Lynch with their lifetime achievement award. Lynch, the Director of Community Programs and Development & Marketing at Boystown, was instrumental in inspiring the AOH to name our newly created and constitutionally approved human dignity award the Father Edward J. Flanagan Human Dignity award. The award to be bestowed initially in Orlando in 2024 and then every two years going forward will recognize an individual or group outstanding in the defense of the unborn or in advocating for those who suffer from injustice, poverty, homelessness, abandonment or other forms of societal neglect.

My sincere thanks to Nebraska State President Mike Addy, Fr. Flanagan Division President Tim Lonergan and LAOH Omaha President Kelly Hajek for their tremendous hospitality during my visit. National leadership attended highly visible events in Washington, D.C., during the yearly St. Patrick's Day events hosted by the Irish, English, North of Ireland and U.S. governments. In March we also announced the nine inaugural recipients of the AOH St. Patrick Centre Young ambassadors program, an innovative progressive new offering to identify and inspire young members aged 18 to 24 to apply for an unforgettable two-week program in Ireland.

Our Freedom for all Ireland Christmas Appeal grants of more than \$160,000, a record amount, were distributed by President O'Connell and FFAI chairman Martin Galvin in Ireland. President O'Connell delivered significant grants to seminarians in Ireland while our Project St. Patrick also achieved historic levels of success.

Finally, in early April, I represented the AOH at the prestigious "Reflections on the Good Friday Agreement, 25 Years of Peace and Progress" at the historic Cooper Union in

I want to start this article by thanking you all for your continued patience and support as we continue to work through the rehabilitation of our beloved National Secretary Ed Halligan. Special thanks to PA AOH President Ed Dougherty for coordinating transportation for Ed to his weekly rehabilitation appointments. Brothers from Philadelphia and Montgomery County are stepping up to help Ed's family during their time of need. The Halligan family wants to thank you all once again for your good wishes, support and prayers. Additionally, I want to recognize the efforts of Maria McDonald in the office.

Here are some of the updates we are working on to better serve our members:

An update of all AOH forms on our website. Our goal is to provide 100 percent online access to all forms so that our leadership and membership can easily download any form. This will eliminate the need to order forms from the national office. When finalized all forms will be PDF fillable and include our updated logos.

Our charters are finally being digitized so that going forward the ordering or new or replacement charters will be a much easier efficient process.

We have made great progress in improving address validation of our membership rosters. A member's correct address is the absolute minimum we must have in our roster system. Members with invalid or missing addresses are not receiving their membership benefit of the Hibernian Digest, do not receive the yearly Hibernian Charity mailing and have incorrect or missing information on membership cards. Based on information we receive from the US Post Office (USPS) and reports available from our printer of the Hibernian Digest we have updated over 1,700 addresses. The next upgrade to the roster system will include address verification, which will require correct addresses, so it would benefit all divisions to start correcting this issue now.

Working with our National Organizer Ryan Curry we are working on better follow up and decontrol of the processing of online applications. We need to do a better job of following up on those applications in a timely manner and getting those prospective new members initiated as soon as possible.

   membership cards directly.
- Send a form with a check. It is easier for record keeping purposes to have them together. Emailing forms can usually guarantee lost information. Checks sent without proper documentation can result in insufficient information recorded.

This is indeed good news for all as it shows that getting the word out about these programs makes the AOH the largest most influential Irish organization in the country.



# irish american beritage month

Another March and Irish American Heritage Month 2023 is in the books. I thank all of you who have written and informed me that your state and communities backed our Hibernian President's call to recognize the contributions the Irish American men and women have made by having your own local proclamation and recognition of Irish American Heritage Month.

On the National Level, our Irish American Heritage Month video reached 410,000 people and gathered over 8,000 Likes and 3,300 Shares across the nation, including areas where we, at the moment, do not enjoy a strong AOH presence. On average, the post in our daily profile series generated more than 2,000 Likes apiece. I think we can take some pride in our success in 'perpetuating the history and traditions of the Irish people' while also getting the name of the Ancient Order of Hibernians out to the broader public. It has been heartening to note that we are seeing "Irish American Heritage Month" enter the U.S. vocabulary, especially in the print media.

The question is, did you and your division, county or state participate and take advantage of Irish American Heritage Month? If not, why not? We are all very concerned about our membership numbers; here was an opportunity to both do the 'good work' of the Order and promote ourselves as an organization. If we are not taking advantage of it, it is a squandered opportunity.

We are entering State convention season, and I ask that serious consideration be given when you convene on what you are doing to promote Irish Heritage and Irish American Heritage Month and what more can be done. Irish American Heritage Month is both a duty and a pragmatic opportunity and should be an essential state program.

Brothers, it is not a characteristic of the Irish to rest on their laurels, and our success with our National Irish American Heritage Month program should not blind us to the need to increase awareness, especially among our own young people, of what the Irish have done and why they should be proud to be Irish. Ironically, at a time when 'Diversity, Equity and Inclusion' have become almost a mantra, we are seeing the Irish American experience being airbrushed from the American consciousness. Perhaps a trivial barometer, but I was shocked that none of the national movie networks had any Irish content on St. Patrick's Day or the days leading up to it. This is in stark contrast to how they promote other heritages. The story was similar to the educational channels, at least in my area of tri-state New York.

The message is clear:

- If we, as Hibernians, do not promote our Heritage, no one else will.
- If we do not make passing on our Heritage a mission, our young people will not have a sense of Irish identity.
  - Without a sense of Irish identity, our future as an Irish Catholic organization is in peril.



# veterans affairs

Brothers, I hope that your St. Patrick's Day and other Green Season festivities were celebratory and fun. Here in Columbus, we had the most well attended events for our Proclamation Day (the week before St. Patrick's Day) and for the holiday itself. Despite damp, cold and windy weather the public turnout for the parade and the attendance at our city-wide Irish Family Reunion were the largest since prior to the pandemic.

#### **Personal Reflections: Iraq and Vietnam Milestones**

There were two important military history commemorations during the month of March. The 20th day of March marked the 20th anniversary of the invasion that began the Iraq War. On the 29th of March the nation observed Vietnam Veterans' Welcome Home Day in the year where we will commemorate the 50th year since the end of America's involvement in the Vietnam War in 1973.

Both wars have significant personal importance to me. My father and fellow Hibernian, Douglas Eakins, is a veteran of Vietnam along with three of my uncles. Our longest and best family friend, and fellow Hibernian, Michael O'Sullivan, served as a Green Beret in Vietnam and was key in guiding my decision to enlist into Army Officer Candidate School. I grew up in a community where most of the men who were Dad's age had also served in or around Vietnam. While that service always had a deep personal meaning to me, that meaning evolved into a deeper understanding as my journey through enlistment into the Army after September 11th, 2001, and subsequent service as a platoon leader in Iraq in 2005, afforded me the privilege and honor of the title "veteran" myself.

My personal and professional pathways as a veteran and advocate have enabled me to better understand and appreciate the full breadth and diversity of the military, veteran, and family experience. In that vein, I wish to extend my sincere appreciation to all my fellow veterans in our Brotherhood, with a special regard to my comrades-at-arms of the Iraq War, the 9-11 Wars, and the veterans of Vietnam during this milestone year.

#### Veteran Services Spotlight: Efforts to End Military Retiree Benefits Offsets

Current federal policy imposes an offset where veterans who have retired from the military are required to forfeit all or part of their U.S. Department of Veterans Affairs (VA) service-connected disability compensation at a dollar-for-dollar rate. For every dollar earned in military retirement, disability compensation is reduced by a dollar. Companion legislation previously introduced to Congress titled the Major Richard Starr Act (H.R.1282 & S.344) sought to provide relief, at least, to those military retirees who were medically discharged for duty-related injuries and for veterans with combat-related disabilities and fewer than 20 years of service (who were medically retired) to receive the full amount of their disability compensation along with their military retirement pay. The legislation was named after Iraq and Afghanistan veteran Army Major Richard Star, who died in 2021 aged 51, from lung cancer acquired during his service as a combat engineer. Since that legislation withered on the vine, 21 national veteran organizations are pressing the current administration to make concurrent receipt relief a policy priority for the fiscal year 2024 Defense Department budget.

Best wishes to you all for a Happy Easter and for a commemorative and reflective Memorial Day on May 29. All members, especially veterans and VA Chairs, are encouraged to participate in National VA Committee meetings held online, generally the third Tuesday of the month, at 7 p.m. ET. # hibernian hunger project

Hibernians across the USA are absolutely living by the motto of our Order, Friendship, Unity and Christian Charity. Divisions are addressing hunger in their communities in multifaceted ways. In all, 38 Hibernian Hunger Project applications were received. A big THANK YOU to these 38 Divisions who submitted their Hibernian Hunger applications! The Committee reviewed the applications and again found it very difficult to select this year's recipients because of the scope of all the Hunger Projects. In all, the committee selected three Divisions to receive \$1,000 grants, and 11 Division projects were selected to receive \$500 awards.

Divisions selected to receive \$1,000 grants were: Division 1, Douglas County, NE; Division 5, Bucks County, PA; and Division 1, Oneida County, New York.

Father Flanagan Division 1 of Douglas County, NE Hunger Program centers around Divisions 501c3. The Division over the years has donated to a score of charities. In 2022, Division 1 contributed a total of \$10,500 in meat alone to their community, in addition to canned goods, nonperishable goods and paper products. During 2022 Father Flanagan's Division fed well over 20,000 people. The Division's leadership credits their Hibernian Hunger Project's success to buying food and other products in bulk. In the past 10 years, Division 1 has donated more than \$140,000 in food to the Omaha area. A key to their success: all 125 members of Division 1 participate in some way with their time, talent or treasure to Division 1's Hunger Project.

Division 5 of Bucks County, PA, is in their eighth year operating HOPE 101, which is a 501c3. During 2022, the Division was able to serve guests in person for the first time since the pandemic. A private group, Advocates for the Homeless, has buses that drive those in need to their meal program that is prepared at HOPE 101 by members. Division 5 has partnered with the Mother of Mercy House in Philadelphia, to help supply their food pantry. Mother of Mercy is located in a destressed area of Philadelphia.

Division 1 of Oneida County, NY, in 2022 raised money to feed the hungry in their area through multiple fund raisers, including a raffle, a golf tournament, and a coolers of cheer raffle. To help veterans in their area, a fundraiser, the First Annual Mohawk Valley Guinness Pour Contest, was held. Working with first responders in Oneida County, Division 1 helped feed more than 500 families at Thanksgiving. In addition, Division 1 donated \$4,000 to Central New York's Food Bank, which provided \$28,000 worth of food to the hungry in Oneida!

Divisions selected to receive \$500 grants were: Division 2, Hartford County, CT; Division 2, Saint Louis City County, MO; Division 1, Deer Lodge County, MT; Division 16, Passaic NJ; Division 4, Queens County, NY; Division 1, Saratoga County, NY; Division 1, Jefferson County, NY; Division 1, Medina County, OH; Division 32, Allegheny, County, PA; Division 2, Bucks County, PA; and Father Lynch Division, Roanoke, VA. In future Hibernian Digest articles, we will share how each of these Divisions addressed hunger in their areas.

The next round of Hibernian Hunger Project Awards will cover Division Hunger Projects that will take place between January 1 - December 31, 2023. If you have not already done so, now would be a good time, to plan and implement a Hunger-related event. Why not consider some of these projects that have been accomplished by this year's recipients! You might just need to tweak it some to fit your local needs, and in 2024 your Hunger Project just might be one of the award recipients!

#### **Easter Commemoration**

Having spoken at Easter Commemorations in Ireland as well as in America, I can tell you there is a major difference. American commemorations center on the 1916 Easter Rising. Irish Commemorations are more focused on Ireland's patriot dead of more recent times

On Easter Monday I was honored to speak at the commemoration at the Nassau County (NY) Courthouse. The memorial with one large monument surrounded by a number of inscribed stone plaques, is indeed impressive.

Having just returned from Ireland and mindful of the way Easter Monday was being commemorated that day in Tyrone and across the north, I tried to combine both themes.

A seminal event in the Easter Rising had occurred a decade before 1916, when American citizen and Long Island farmer Tom Clarke agreed to return to Ireland as Clan na Gael leader John Devoy's representative, with a mission to unite Republicans and plan a rising. Clarke had already served 15 years in a British prison under brutal conditions. When the Proclamation was being signed the other leaders stepped back and demanded that Clarke's name be above the rest as a sign of his leading role.

Again this past Easter weekend, the 1916 Proclamation had again been read at the graves of Irish patriots who died during the 1969-98 conflict, to signify they had fought and died to achieve the freedom proclaimed over Clarke's name in 1916.

The Good Friday Agreement is being widely celebrated with events marking its 25th anniversary, because the agreement has achieved peace. We join in welcoming the achievement of peace, but we cannot be satisfied until we have freedom for all Ireland.

Among those present were Nassau County AOH President Jack O'Brien, Hibernian Digest Editor John O'Connell, NY State Secretary Tom Beirne, former NY State President Jim Burke and former State FFAI Chair Tim Myles.

#### **Hibernian Grants**

The AOH followed a busy St. Patrick's week of key meetings with Irish and British

political leaders in Washington and New York by presenting Christmas Appeal grants in Ireland. This year, the AOH set a new record with members contributing more than \$160,000.

These presentations followed a St. Patrick's Day week in which the AOH hosted Taoiseach Leo Varadkar and voiced crucial concerns about the pending British amnesty bill in meetings with Irish and British officials and six county party leaders.

Each of those groups spoke about how much our AOH contributions mean to them and their work. Our financial grants are important to them, but it is also the morale boost that Irish America is behind them and that we are a voice for them in Washington.

#### **AOH** presents FFAI grants in Belfast

Nineteen groups from across the six counties joined at the Houben Centre, in Belfast, on April 1, to receive Christmas Appeal grants.

#### Opened

AOH National President Danny O'Connell, after landing in Ireland that morning, opened the event by saying "the AOH is here today distributing a record shattering \$160,000, contributed by AOH members across the United States in a special Christmas Appeal to support work for Freedom for all Ireland.

"When we raised \$100,000 a year ago people said it would never happen again. Our members said it would never happen again because we will be raising much higher amounts and this year is the first example of what they meant!"

He then called Freedom for all Ireland Chairman Martin Galvin, who began by saying: "We are able to award these grants because of the inspiration you give us in America. Our members hear you and see the work you do for Freedom for all Ireland, and want to stand behind you, whether by being a voice for you in Washington or standing behind you financially as we do today."

### **Voice in Washington**

Relatives for Justice, the first grant recipient called upon, was represented by Mark Thompson, who said: "We see the British pushing through an amnesty bill of shame and it means so much to know that the AOH is behind us in Washington, able to get Congressional and Senate support for us as well as making donations that are vital to what RfJ does."

Next, Maeve McLaughlin, of the Bloody Sunday Trust, said, "The Bloody Sunday Families have spent decades fighting for justice. The AOH has been with us for much of that fight and we welcome your help and support today."

Frankie Quinn, of EALU (meaning Escape), a Tyrone support group for former

political prisoners described the vital job training and counseling EALU is able to provide for ex-prisoners with AOH help.

Joe Austin accepted the grant for Belfast National Graves and said, "It is especially important during Easter Week that the families of Irish patriots see that the graves and memory of their fallen loved ones is honored and AOH contribution is a major help to us."

Niall Murphy, for Ireland's Future said: "I have personally admired the work, solidarity and understanding of the AOH. Your financial and political help can be a major boost in securing and winning a referendum for Irish reunification."

### Joe Doherty

Perhaps the loudest cheer came when the representative of the Greater New Lodge Cultural was introduced, "as the man who had a New York street named for him while inside a New York prison, Joe Doherty." Joe Doherty talked about the impact of years of struggle on New Lodge and the work his group does particularly with young people in the area.

Bogside artist Tom Kelly said the AOH donation will help preserve the iconic political murals in Derry's Bogside.

#### Awards

Other successful grant recipients were Tyrone National Graves, Ballymurphy Massacre Campaign, St. Patrick Centre, Green Cross, the O'Neill-Allsopp Memorial Band, Duchas-Oriall, Martin McGuinness Peace Foundation, the Witness Project and cross-community groups, including Bridges Beyond Boxing, Omagh Choir, and Omagh Thunder Basketball.

Fr. Gary Donegan, whose Passionate Peace and Reconciliation Centre hosted the event, was the final recipient and talked about working for reconciliation in Ardoyne. Others who traveled to the Houben Centre for the event included Malachy McAllister, New York State President John Manning, New York State FFAI Chair Vince Tyer and former State Director Brian Kelly.

As you are aware, the Ancient Order of Hibernians has continued to push very hard for a revision of the current E3 Visa to allow approximately 5,000 unused visas, from the 10,500 visas previously allocated to Australia, to be reallocated to Ireland on an annual basis. It was hoped that such a revision would be agreed to during this past "lame duck" session of Congress. This did not occur. It was then hoped that action would occur during the current Congress. However, immigration issues have not been successfully dealt with during either session.

As Hibernians, we have learned to be patient. However, our patience is being tested. Patience remains the watchword on the immigration front. Although continued patience in this area is difficult, we as Hibernians need to hang tough for a while longer. We have no choice! We must still have hope that we may see immigration bills passed before the end of the year.

The Ancient Order of Hibernians continues to work with our elected leaders in Washington to maintain a "vital relationship" with the Irish government. Recently, the AOH and Irish Central hosted Taoiseach Leo Varadkar in Washington, D.C. during St. Patrick's Day week. The AOH also hosted many of our nation's Congressional leaders during the same week. Our work continues!

Dearly beloved brothers, in Christ, Jesus and St. Patrick, Jesus Christ is truly risen; He is truly risen. Alleluia!

This year, due to a bout with A-Fib, I spent almost the entire Holy Week in the hospital. I'm fine now, so there's nothing to worry about, but it did give me a lot of time to contemplate several life issues. For one thing, it was the first time that I had been admitted to an emergency room, and they asked what level of effort should be put forth to revive me, should I pass away under their care. Did I want to be resuscitated, to what degree did I want to depend on machines, and other important information, relying on the use of technology to possibly extend my life. It was the first time I had to deal with end-of-life issues in the first party. Consequently, if you don't already have a Living Will, it is a good idea to have one completed, or added to your existing will.

Although not quite as controversial as abortion, End of Life situations are being dealt with very differently across the United States. There are currently 11 states that offer assisted suicide. Frequently, economic, social, independence, chronic pain, becoming a burden, and other issues not mentioned arise when dealing with natural end of life situations, especially with the elderly and disabled. According to Catholic teachings, only God has the right to determine when someone's natural life on earth comes to an end. In addition to being a direct violation of the Fifth Commandment, Thou Shalt Not Kill, it also violates the Fourth Commandment, Honor Thy Mother and Thy Father. Not having Social Security, Medicare, 401k's, and Pensions, the Fourth Commandment was written for the Israelites, who had to maintain the life of their elderly parents, with dignity, even though they may have become a burden.

Towards the end of my stay in the hospital, I was able to watch a technician create an analytic video of my beating heart. I was in complete amazement, as I watched my heart, that began beating in my mother's womb. Watching the monitor made me think about the heartbeat laws that have been passed in many states. To actually see the heart beating inside the chest of someone, whether they're born or unborn, is absolutely magnificent, and you can almost see the hand of God at work making the heart beat every single time. The experience also made me think about laws that have been proposed to force abortion clinics to show the abortive mother a sonogram of her live baby inside her womb. How could anyone face-to-face with her unborn child, see the unborn child's beating heart, and still decide to end that life.

Hopefully you all enjoy a great State convention season, and hopefully all State Boards will appoint Pro Life Chairman, and those states will promote appointment of County Pro Life chairs, and those counties will promote the assignment of Pro Life Chairs at every Division. Only with true Catholic teachings and thorough education can we offset the barrage of false teachings being propagated by media of all sorts. # catholic action

Given what has been going on in the healthcare field of late, the United States Conference of Catholic Bishops (USCCB) has recently given us some timely guidance. On March 15, the Conference's administrative arm released a "Doctrinal Note on the Moral Limits to Technological Manipulation of the Human Body." The 14-page document was prepared by the Conference's Committee on Doctrine, chaired by the Most Reverend Daniel Flores, Bishop of Brownsville. In its preparation, the bishops sought the advice of numerous parties, including medical ethicists, doctors, psychologists and moral theologians. Though the document is primarily directed to healthcare professionals, it is also a useful guide to all of us trying to navigate our healthcare system.

The bishops note that today medical practice has at its disposal an amazing range of options, unfortunately, not all of which are moral goods, at least in all circumstances. To aid in discernment here, they lead us through a quick review of some basic truths.

"A fundamental tenet of the Christian faith is that there is an order in the natural world that was designed by its Creator and that this order is good." This is especially true of humans, made in the image and likeness of God. Respect for human dignity requires that decisions made about the use of medical technology must be guided by the natural order. Two crucial aspects of the natural order for humans are that the body is an intrinsic part of the human person — and not simply a machine being used by the soul — and that

our bodiliness is intrinsically connected with sexual differentiation. "Male and female He created them (Genesis 1:27)." This is not then a changeable individual choice. To think so is to usurp the role of the Creator; indeed, adopting this attitude regarding sexual identity easily spills over into thinking that we enjoy absolute power over all of creation.

The Church's moral tradition recognizes two situations in which technological intervention on the human body may be morally justified. One is to repair a defect in the body. We are obliged to use ordinary means to preserve health. Intervention in these circumstances is not without limits: the obligation to intervene no longer holds when the benefits of intervention are no longer proportionate to the burdens involved.

The second situation arises when it is necessary to sacrifice a body part for the wellbeing of the whole body. We may not wantonly destroy or mutilate the body, but there are situations when the welfare of the body as a whole warrants the destruction or removal of part of it.

However, we are faced today with attempts, not to repair the human body or to preserve its general wellbeing, but to fundamentally alter it, in a way which flies in the face of the truths outlined above. Some such attempts are only in experimental stages, e.g., non-therapeutic manipulation of human genetic material or "cybernetic enhancement." But there is one type which is widely practiced today, indeed, seems to be almost a healthcare fad, and that is the attempt, by chemical or surgical means, to change human gender in response to "gender dysphoria" or "gender incongruence."

Our bishops are forthright in saying that these practices have no place in a Catholic healthcare system. Technology must respect the fundamental order of creation. We may not substitute ourselves for the Creator.

# history report

The role of the British Monarchy, according to the Monarchy, is to serve as a "focus for national identity, unity and pride..." (https://www.royal.uk/role-monarchy). This put Albert Edward of Saxe-Coburg and Gotha in a bit of a spot in 1901, as he contemplated his coronation as Edward VII. Edward had become the "focus of national unity" upon the death of Queen Victoria on January 22, 1901, and, by happenstance of birth, would be crowned, "by the Grace of God" as King of the "United Kingdom of Great Britain and

As required by law, Edward would solemnly declare "that in the Sacrament of the Lord's Supper there is not any transubstantiation of the bread and wine into the body and blood of Christ ...and that the ...adoration of the Virgin Mary ... and the Sacrifice of the Mass, as they are now used in the Church of Rome, are superstitious and idolatrous." What better way to unify the nation than to denigrate the religious faith of several million of his Majesties' "idolatrous" Irish-Catholics subjects. Edward, crowned on August 9, 1902, had the common sense to be reluctant to say the quiet part out loud, but say it he did after Parliament failed to pass an act removing the anti-Catholic language. The record of the 1901 debate in Parliament, a remarkable testament to the entrenched bigotry of the British establishment, includes a gem of a rhetorical question posed by Patrick O'Brien, Member for Kilkenny, who asked Lord Balfour: "Would the right honorable Gentleman have any objection to having a copy of the ... oath sent to Irish Catholic soldiers now serving in South Africa?"

The declaration was finally altered before the coronation George V, in 1911, but while the quiet part is no longer said out loud, the role of Head of State of the United Kingdom is still off limits to Catholics. The British Constitution specifically requires that Monarch may not be a Catholic or even married to one.

In 2011, the "Mother of Parliaments" "modernized" the law to allow the Monarch to be married to a Catholic (but not be one), because, as Prime Minister Cameron proudly declared, "after all, [the Monarch] is free to marry someone of any other faith." Apologists justify excluding Catholics by noting that the Monarch is also the head of the established Church of England. This of course is why our Constitution includes the First Amendment ("Congress shall make no law respecting the establishment of religion....").

The Monarch, the argument goes, is merely a figurehead and the Prime Minister is the head of Government, so no harm no foul if Catholics are excluded. And yet the Prime Minister too has a legal role in the established church, recommending Bishops for appointment by the Monarch, and it is a crime for a Roman Catholic to advise the Monarch on any appointment in the established church. Tony Blair, notably, converted to Catholicism only after he left office, not wishing to provoke a constitutional crisis. When Boris Johnson became the first Catholic Prime Minister, British constitutional experts provided the solution - Johnson would have to delegate responsibility for church appointments to the Chancellor of the Exchequer. Current Prime Minister Sunak, a Hindu, on the other hand, is free to weigh in on such appointments, given that he is not Catholic.

Next month, as anachronistic spectacles unfold in London, we should be grateful that we live, by the Grace of God, in a Constitutional Democracy, in which the 14th amendment to our Constitution provides that no state shall deny any person, of any religion, "the equal protection of the laws."

Manning (New York State President, The Ancient Order of Hibernians in America) during which Mr. O'Connell made a presentation of a donation towards the formation of seminarians for the diocesan priesthood in Ireland. They met with the President of St Patrick's College, Rev. Professor Michael Mullaney, and with Fr. Tomás Surlis and members of the Community of Formators in the National Seminary. 



**JOSEPH W. KELLY**, 83, of Waterbury, Ct., passed away unexpectedly at Saint Mary's Hospital on February 24, 2023. He was the beloved husband of Hilda (Desmarais) Kelly.

Joe was an active member in several local organizations, including the Ancient Order of Hibernians Monsignor Slocum Division 1, where he was one of the last surviving leaders who helped to revive the Division.

One of Joe's happiest days was the day he was honored as the Waterbury "Irish" Mayor for the Day in 2011, and was also proud to have had the opportunity to serve as the Saint Patrick's Day Parade Marshal. He was a quiet, humble man who was extremely proud of his Irish heritage.

Jimmy went on to teach scores of young musicians who went on to win competitions in the U.S. and Ireland.

In 2000, he was inducted into the Irish Traditional Music Hall Of Fame and acclaimed "the finest Ceili drummer in America."

He was also always happy to play his second instrument, the two-row button accordion at many gatherings.

Jimmy met his wife of almost 60 years in his family's Irish resort "Kelly's Brookside" in East Durham, NY. They married and moved to Albany, where he worked at Schaefer Brewery until they closed, eventually retiring from Albany County Sewer District in 2002.

Jimmy and his wife Ann, always known for their hospitality, hosted many concerts in their home which came to be known as "Kelly's Basement Concert Series" featuring world class Irish musicians.

His faith was very important to him. He was always carrying rosary beads. He was a big supporter of Father Peyton's Family Rosary and was instrumental in collecting one million rosaries for them to be distributed worldwide.

Jimmy will be remembered for his appreciation of the little things, his quick wit, puns, making people feel comfortable, his work ethic, his love of music, but especially for his love for his wife and family.

Jimmy was born Sept. 28, 1940, in Manhattan, NY, son of Ralph and Theresa Kelly. He was the second of five children, Ralph (Mary), Kevin (Phyllis), Theresa (John), and predeceased by Brendan (Sheila). He is survived by his wife Anna Mary (Leonard), his four children Anna Mary Kelly, Maura Bruda (Bob), Denis, James Jr., his five grandchildren, Cyrus Rivet (Erin), Celia Rivet, Joseph Juliano Jr., Niamh and Shane Kelly and great grandson Arthur Rivet. 

#### Division 'Zooms' with Seamus Kearney

Last year on December 8, Division 5, of Bucks County, Pa., had the privilege of hosting a Zoom meeting with Seamus Kearney, author of "No Greater Love." This book chronicles his time in the IRA and time spent in the H blocks of Long Kesh Detention Center (later known as Her Majesty's Prison Maze).

In the book, Kearney speaks about the physical, emotional abuse and starvation suffered at the hands of his guards. He talks about his time as a part of the Blanket protests at Long Kesh and his friendships with Bobby Sands and the other Hunger Strikers, as well as Brendan Hughes, known as, "The Dark." It was also at this time that he learned of the execution of his brother Michael at the hands of the IRA for being a suspected informant. Seamus later learned that this was actually a plan hatched by the actual informer, an individual code named, "Stakeknife."

Several times during the retelling, Seamus would stop and collect himself before going on. All of this occurred in a room so quiet that you could hear a pin drop. Everyone in the room sat quietly, respectfully waiting for him to resume.

In writing his book, Seamus hopes to bring to light Britain's attempt to minimize and/or criminalizing their fight for a free, united Ireland. One example that Seamus pointed out was Britain's attempt to declare amnesty for all crimes committed during the struggles, which could have conceivably pardoned individuals of their murderous activities.
